NON-AFFILIATES	Companies not related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none">· <i>Non-affiliates we share with can include lenders, collection agencies, consumer reporting agencies, debt buyers, payday lenders, deferred presentment providers, delayed deposit providers, check cashers, credit card companies, money transfer service providers, tax service providers, retailers, database providers and others.</i>
JOINT MARKETING	A formal agreement between non-affiliated Financial Companies that together market financial products or services to you. <ul style="list-style-type: none">· <i>Our joint marketing partners include lenders, payday lenders, credit card companies, money transfer service providers, tax service providers and others.</i>
